## COVID-19 Cases Update

St. Joseph County- As of today, St. Joseph County is reporting 1,341 active cases (red as it relates to County metrics), and our average is 112.6 cases per day (red) in the last seven days. The county's R0 estimate is 0.99 (yellow). Test positivity rate is 5.1% (as of 10/9/2020) (yellow).

Several CVS locations in the county may also offer weekend testing. Individuals seeking a COVID-19 test are encouraged to follow up with their primary care provider and consult the testing location before arriving.

The St. Joseph County Department of Health urges the continuation of the following actions:

- **Practice extreme physical distancing.**
  - Maintain at least 6ft between individuals.
  - Wearing a mask does NOT eliminate the need for physical distancing.
- **Practice frequent and proper hand hygiene & cough etiquette.**
  - Wash hands often, for at least 20 seconds, with soap & water; coughing and sneezing into your sleeve.
- **Stay home if ill.**
- **Limit indoor social gatherings to less than ten people.**
- **Abide by the current Public Health Order, requiring face coverings when going into an enclosed public space or business and when 6 feet of physical distance cannot be maintained within the enclosed public space or business.**
